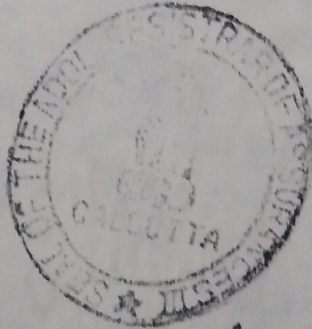

**WHEREAS** the **FOUNDER / SETTLOR / AUTHOR OF THE TRUST** being desirous of setting up a Public Charitable Trust to provide relief and take welfare measures to ameliorate the social and economic condition of people at large, for the benefit of all persons belonging to whatever community without any discrimination as to caste, creed and religion and to undertake care, help, provide valuable services and with such objects in view held a meeting at A-17/304 Peerless Nagar, P.O: Panihati, Kolkata: 700114 on..... December, 2015 and in that meeting adopted a resolution to establish and create a Trust under the name and style of **"RESCUE AND RELIEF FOUNDATION"** with the objects and constitution as hereinafter set forth;

**AND WHEREAS** with the said objects in view, the **FOUNDERS / SETTLORS / AUTHORS OF THE TRUST** have decided to endow the said TRUST, a nucleus of a sum of Rs. 10,000.00 (Rupees Ten thousand only), and said total amount hereinafter referred to as 'the Corpus' of the Trust and **FOUNDER / SETTLER / AUTHOR OF THE TRUST** this day have transferred the said 'corpus' unto the Trust Fund constituted herein to carry out the objects of the Trust. It is necessary and desirable to declare and constitute the said Trust and to record the objects and constitution of the said Trust;

**AND WHEREAS** the persons named as the Trustees created hereunder have accorded their assent for acting as Trustee by accepting the amount

settled unto the said Board, being the subject matter of the Trust as aforesaid;

**AND WHEREAS** the Founder / Settler / Author of the Trust herein have considered it necessary, expedient and desirable to declare and constitute the said Trust and to record the objects, constitution and other terms of the said Trust by a Registered Deed of Trust for permanent, proper and regular functioning of the said Trust to promote its objects;

**NOW THIS DEED OF DECLARATION OF TRUST WITNESSETH AS FOLLOWS:**

**DECLARATION:**

1. The Founder / Settler / Author of the Trust do hereby declare that he has transferred a sum of Rs.10,000/- (Rupees Ten thousand only) unto the Trust Fund constituted as the initial 'corpus' of the trust for the objects stated hereunder.
2. The Trustees do hereby declare and confirm that they hold the aforesaid 'corpus' fund as made over to them and all other money and fund as and when vest upon them shall be used solely and exclusively for the purpose and objects of the Trust.

**NAME:**

The name of the Trust shall be **"RESCUE AND RELIEF FOUNDATION "**.

**DATE OF EFFECT:**

The trust has come into effect and shall always be deemed to have come into effect with effect from 1<sup>st</sup> DECEMBER 2015.

**REGISTERED OFFICE OF THE TRUST:**

The office of the trust shall be situated at A-17/304 Peerless Nagar, P.O: Panihati, Kolkata: 700114 which may be shifted to such other place or places from time to time as the trustees may deem fit and proper at their discretion subject of observance of rules enjoined for it;

**OBJECTS:****A. PRINCIPAL OBJECTS -**

1. Promote awareness among parents about importance of education.
2. To bring non-school going children to the school system and retain them.
3. To use education system as a tool to make students confident and socially responsible.
4. To arrange education for parents of school going children.
5. Provide children with materials/utilities/tools for study, instruments for performing arts and equipment and training for sports.

6. Train teachers and periodically upgrade their knowledge and methodology so that they can provide best in class education.
7. To establish, maintain and run Schools, Colleges, Social service centres, Industrial Training centres.
8. To establish science laboratory, centre for performing arts to make education interesting and enjoyable for students.
9. Make students conscious about natural resources and environment health and safety and promote cleanliness.
10. To promote awareness and public education about Diseases.(Children education, supporting old age people, diseases, victims of natural calamities or otherwise
11. To advocate for the rights of people with Diseases so that they live with dignity.
12. To establish strong research base on Sociological and Psychological impacts of Diseases.
13. To collaborate with scientific agencies, research organisations, educational institutions on specific projects related to Diseases.
14. To propagate and spread the teachings of humanity and mankind to ensure the peace, prosperity and progress of all sectors of the society and people as a whole.
15. To ameliorate and advance the condition and status of poor, helpless, aged, disabled and needy person of the society, suffering from Diseases, as a whole without any discrimination whatsoever.



16. To establish and sponsor educational, cultural, spiritual and philanthropic institutions and organizations for diffusion of useful knowledge relating to Diseases and attainment of overall development of society.
17. To build and raise funds to carry and implement the objects and to aid, assist and finance the eligible persons suffering from Diseases covered by the objects of the trust.
18. To provide aid, assistance, help, ailment, advice to the Diseases suffering patients and probable Diseases suspected individuals of all communities irrespective of their race, religions, cast or creed in general.
19. To provide medication, equipment, accessories and other supplies relating to Diseases aid and assistance. In addition to that address physical, emotional and mental pain and agony by predominantly focussing upon care, symptom management and pain control.
20. To formulate, prepare, incorporate or put together a team of doctors, nurses, social workers, certified nursing assistants and volunteers who would provide assistance based on their area of expertise as and when their need arises.
21. To employ or engage or delegate other organizations, institutions or agencies, temporarily or in regular employment for accounts, professional expertise, fund collection, skilled workers, technical advisors, consultants, managers or any other persons in order to

provide valuable inputs and services whenever required as may be considered expedient and commensurate with the need or requirement or demand as mandated upon the organization or individual personnel.

22. To receive financial assistance, in the shape of loan or otherwise, from Government, Non - Government organizations, banks or any other legal entity on reasonable terms and conditions.
23. To accept donations, grants, presents and other offerings ( in the shape of movable or immovable properties) from any individual, institution or organization, both domestic and foreign, and the same be utilized for the promotion of aims and objects of the Trust.
24. To purchase or hire permanently or temporarily, vehicle or vehicles for transportation purposes and to do or perform any other act which may be incidental or complete to the attainment of any of the object of the Trust.

#### **B. ANCILLARY OBJECTS**

- 1.a) To arrange for the scholarships, financial assistance/aid, endowments for the education of the needy students and diseases affected children undergoing treatment and their parents.
- b) To grant relief during natural and national calamities such as earthquake, flood, famine, fire, pestilence and other occasion of calamities of similar nature and to give donations, subscription or

contributions to institutions, establishments or persons doing such relief work;

- c) To give, provide and/or render education, food, medicine, insurance and other help and/or assistance in any shape or form, to the poor, handicapped, aged, deserving and needy;
- d) To give, provide and/or render help and assistance to and/or implement any scheme for providing livelihood and upliftment of the poor of the society and suffering from Diseases.
- e) To organize training programmes, lectures, seminars, symposia, conferences and performances with a view to make the general public aware, familiar with and to appreciate the qualitative and new trends emerging in the treatment of Diseases and also education for all.
- f) To establish, run, maintain and fund schools, educational institutions, hospitals, old age homes, dispensaries, health centres and medical units for general public without any discrimination as to caste, creed, religion and sex;
- g) To arrange and organize old-age-home to help the needy people of the society without profit motive.

2. If any one or more of the objects specified in clause hereinabove of these presents are held not to be objects of a public charitable nature, the trustees shall not carry out such object or objects as if the same are not

incorporated in these presents but the validity of the trust created by these presents as a trust for public charitable purposes shall not be affected in any manner.

**BENEFICIARIES OF THE TRUST:**

This Trust is created for extending the benefits detailed in the objects of the Trust for all communities irrespective of their race, religions, caste or creed in general.

**FIRST AND FOUNDER TRUSTEES:**

a) In the meeting of the FOUNDERS held aforesaid, it has been resolved to appoint the following persons as the FIRST AND FOUNDER TRUSTEES OF THE TRUST to hold the office of the Trust as Trustees:

**BY**

1. Mr. Sidhant Ghosh, son of Mr. Swapan Ghosh, by faith Hindu, resident of A/17/304, Peerless Nagar, P.O.: Panihati, P.S.: Khardah, Kolkata -700114, North 24 Parganas, West Bengal.
  2. Mohammad Danish, son of Mohammad Shanshah, by faith Muslim, resident of 34, Park Road, Barrackpur Cantoment, P.O.: Aswini Nagar, P.S.: Barrackpur, Kolkata - 700120, North 24 Parganas, West Bengal.
- b) The FIRST AND FOUNDER TRUSTEES named hereinabove have agreed to and given consent to act as FIRST AND FOUNDER TRUSTEES of the Trust.

c) In case of any death or incapacitation or disability of any of the Founders Trustees hereto, he shall be replaced by his nominee, successor, inheritors, executors, administrators, assigns

1. For the purpose of carrying out such objects as aforesaid the Trustees shall be entitled to by a resolution passed by a majority of those present at the meeting when resolution is considered or by a majority of their number, if it is a circular resolution to carry on such business or businesses with Trust Funds as they may think fit from time to time and to close and restart any of such business or businesses and shall be entitled to do all acts, matters and things which an ordinary business man is entitled to do. All this will be done in the spirit indicated above.

2. All the funds and income of the trust shall be solely utilized only towards the objectives of the trust and no portion of it shall be utilized for payment to trustees by way of profit, interest, dividend, etc.

3. For the purpose of and in the course of carrying out the aforesaid objects or any of them and in addition to the different powers conferred on the Trustees by these presents and without prejudice to the same but subject to clauses 4, 5 and 6 herein before mentioned, the Trustees shall have all the normal powers including the following viz.

4. In so far as it is not inconsistent with the provisions of clause 4, to use, occupy and employ or to permit the use, occupation and employment

of all or any of the trust properties or assets in such manner and for such purposes., and times as they shall consider beneficial for and conducive to the purposes and interests of the Trust.

- to raise, collect and receive moneys required for all or any of the purposes of the Trust, by way of subscriptions, gifts, donations or benefactions in cash and/or by borrowing from individuals, association, trusts, societies, companies, organizations, Govt. etc. with or without security;
  - to acquire and, develop by all lawful means land, buildings, playgrounds and/or any other immovable or moveable property or assets of whatsoever tenure by purchase and to employ persons under the Trust on such terms as the Trustees may deem fit and to discharge them;
  - to acquire, purchase, build, construct or take on lease or in exchange of hire any moveable or immovable property or rights or privileges;
  - Generally to do all such acts, deeds and things; necessary, conducive, suitable or incidental to .or for the attainment of the objects of the Trust or any part of any of them,
5. The Trustees may accept any donations or contribution in cash or kind from any person or persons for the furtherance of the objects of the Trust or more of them upon such terms and conditions as they may in

their absolute discretion think fit and not inconsistent with the objects of the Trust. The Trustees may also take over the management of any other charitable or public institutions on such terms as they think fit and may manage such institutions.

6. The trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in the course of management of Trust properties or in relation to the carrying out of the objects and purposes of the Trust as well as of all the assets, credits and effects of the Trust properties. The Trustees shall also cause accounts to be kept and such accounts will be audited by a qualified auditor every year.

7. Subject to the proviso hereunder the Trustees may at their absolute discretion invest the Trust Fund either in the purchase or mortgage of immoveable property including leasehold property or in such investments authorized by the Indian Trust Act, 1882 in shares or debentures of any Public Sector Undertakings and Public Sector Banks or Scheduled Banks and other Undertakings under above acts and/or Public Trust Act, and on such terms as to interest as the Trustees may think proper with power to the Trustees to alter, vary or transpose such investments from time to time in such manner as they may in their absolute discretion think fit,

Provided that the Trustees shall make investments of the Trust funds, both capital and revenue, only in the modes permitted under the Income Tax Act.

8. The Trustees may from time to time open and maintain in the name of the Trust banking account or accounts and may operate the same or authorize any two or more of them from time to time to operate the same, and to draw, make, sign endorse or discount cheques, bills, notes, securities, Govt. promissory notes, loans, debentures, and other negotiable instruments.

9. The Trustees shall be at liberty to sell, transfer, exchange mortgage, charge, lease and dispose off or otherwise deal with such portion or portions of the moveable or immoveable, properties, assets, etc. forming part of the Trust fund either by public auction or by private contract at such price or prices and on such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to buy in, rescind or vary any contract for the sale thereof and/or resell the same without being answerable for any loss occasioned thereby and for that purpose to execute all necessary effectual receipts and discharges for all money received by them.

10. The Trustees may raise or borrow money or receive money as deposits required for the purposes or for carrying out any of the object or activities of the Trust, on a mortgage, hypothecation or pledge of the Trust properties or any part thereof or without any security and at such rate of interest and on such terms as they may in their absolute discretion think fit, from public or financial institution company or firms etc.



11. The Trustees may construct, maintain, repair, alter extend or enlarge any immoveable or moveable properties or assets of the trust estate and pay all charges and outgoings payable in respect thereof and may incur all other post, charges and expenses of and incidental to the administration and management of the trust estate and the properties for the time being belonging to the trust as they may in their absolute discretion think fit.

12. The Trustees may demise the immoveable property or properties, for the time being and from time to time belonging to the trust either from year to year or for any less term or for any term of years or on monthly tenancies at such rent and subject to such conditions and terms as they may think proper and also accept surrenders of leases and tenancies and generally manage the same in such manner as they think proper.

13. The Trustees shall have full power to initiate, start, defend, compromise and compound all actions, suits, appeals, writs, arbitration and other proceedings and all differences and disputes touching the Trust estate and/or the trust properties and/or refer any such differences or disputes to arbitration, and to adjust and settle all accounts relating to the Trust estate and/or the trust properties and to do all other acts and things as fully and effectually as if they were absolutely entitled to the Trust estate and trust properties without being liable or answerable for any loss occasioned thereby.

14. The Trustees may by a resolution delegate any or all of their powers referred to' in the above paragraph to the Managing Trustee or any other Trustee/s to act on their behalf if he feels that the matter is urgent and time does not permit for the meeting of the Board of Trustees to be held. In such cases, the managing trustee shall subsequently get the action, ratified by the Board of Trustees as soon as possible.

15. The Trustees may frame and vary schemes and rules and regulations for the carrying out of the objects of the trust and for the management and running of any institution established, run or aided by them and for managing the affairs of the Trust and otherwise for giving effect to the objects and purposes of the Trust as the trustees may in their absolute discretion think fit and proper.

16. The Trustees shall be entitled at their discretion from time to time to start, discontinue, abolish and restart any charity or charitable institution to impose any condition or conditions to any subscription or donation made by them and to earmark any portion or all of the Trust property or income for any particular object or objects of the trust. The Trustees shall be entitled to charge such fees as they in their absolute discretion think fit to persons taking advantage of the charity hereby created.

17. The receipt of the Trustees for any moneys, stocks, funds, shares, securities or investments paid, delivered or transferred to them in execution of the Trust or powers here of shall effectually release and discharge the person or, persons paying, delivering or transferring the same, and from seeing or from being bound to see to the application or being answerable for the loss or misapplication thereof.

18. The trustees shall be respectively chargeable only for such moneys, stocks, shares, funds and securities as they shall actually receive notwithstanding their respectively signing a receipt jointly with others for the sake of conformity and shall be answerable and accountable for their own accounts, receipts neglects and defaults respectively and shall not be answerable one for the other or others of them, nor for any banker, broker or other person with whom or into whose hands, any trust moneys or securities may come or be deposited or given for the insufficiency or deficiency of any stocks, shares, funds or other securities nor for any other loss, unless the same shall happen through their willful default or negligence.

19. The trustees may reimburse themselves and pay and discharge out of the trust all expenses incurred in or about the execution of the Trusts or any of their duties under these presents.

20. The number of trustees shall not be less than 2 and not more than 9.

21. The term of the present Trustees shall be for a period of three years. Thereafter Trustees will be nominated by the Trustees.

22. The trustees shall give one month's notice in writing to the nominating body to fill up the vacancies that may occur or are likely to occur.

23. The surviving or continuing trustees may act notwithstanding any vacancy in their body.

24. The Trustees may appoint one of the Trustees as the Managing Trustee for such time as may be determined by the Trustees and such managing trustee shall continue to act as such until another managing trustee is appointed in his place. Subject, to the general control and supervision of the trustees, the Managing Trustee shall have all the necessary powers and authorities for the purpose, including the powers to delegate any of his authorities and powers to such person or persons as he thinks fit.

25. The Managing Trustee may at his discretion and shall upon a requisition in writing signed by anyone or more of the trustees specifying the objects for which the meeting is desired convene a meeting of the Trustees. If the Managing Trustee fails to hold such meeting within a fortnight from the date of the service of such requisition the Trustee or Trustees making such requisition may himself or themselves convene a

meeting of the Trustees but no business other than what is specified in the requisition shall be transacted at such meeting.

26. The Trustees may appoint one of the Trustees as chairman of the Board of Trustees for such period as they think fit. The Chairman shall preside over the meeting of the Trustees and exercise such powers as may from time to time be delegated to him.

27. Two trustees present at the meeting shall form a quorum for any meeting of the Trustees.

28. If at any meeting the Chairman is not present within fifteen minutes of the time appointed for the meeting, the Trustees present shall choose one of themselves to be the Chairman of such meeting.

29. All questions arising at the meeting of the Trustees shall be decided by a majority of votes and in case of equality of votes the Chairman shall have a casting vote.

30. The Trustees may delegate any of their powers to an individual or individuals or a committee or committees or sub-committees consisting of such person or persons whether member of their body or not as they may think fit and appoint such committee or sub-committee as they may from time to time fit for any of the purposes of the Trust and may frame rules relating thereto and from time to time add to or vary the same as they think fit.

31. Any Trustee may with the consent of a majority of the other Trustees delegate in writing all or any of his powers under these presents to his nominee who will be entitled to exercise such powers or power in the same manner as the Trustee himself. Could do personally.

32. A resolution in writing circulated amongst all the Trustees and passed by a majority of the Trustees shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened.

33. Notice of the meeting of the Trustees and all communications may be sent to the Trustees at their address registered for the time being in the records of the Trust.

34. All meetings of the Trustees shall be held at such place as the Trustees may from time to time decide.

35. A trustee who is unable to be present at a meeting of the Trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be his votes on the matters concerned.

36. The minutes of the proceedings of every meeting of the Trustees shall be entered in a book to be kept for that purpose and signed by the Chairman of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.

37. No person being (i) an undischarged insolvent or (ii) convicted of an offence involving moral turpitude or (iii) of unsound mind or (iv) minor, shall be eligible to be a Trustee.

38. The Trustees shall be entitled to frame rules, add to and/or alter them from time to time as circumstances may require for regulating their meetings or for governance, management and administration of the Trust property or otherwise as to them may appear fit and proper.

39. A person shall cease to be a Trustee in any of the following<sup>a</sup> events:

- a) if he dies;
- b) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year whichever is longer;
- c) if he comes bankrupt;
- d) if he becomes insane or otherwise becomes incapable to act
- e) if he resigns his office or
- f) if the nominating authority withdraws the nomination-

40. On a new Trustee being appointed and on his signing the minute book to the effect of his taking possession, the Trust property shall vest in him along with the other Trustees for the time being and he will be entitled to carry out all the duties and functions of a Trustee.

41. Any amendment of the trust deed that may be made on a future date shall be carried out only with the approval of the Commissioner of Income Tax.

42. In case it become necessary to wind up or otherwise determine this Trust for whatsoever reason, neither the Settlers nor the Trustees for the time being nor any other person shall have any right over the funds and or properties of the Trust in any manner .

43. The net funds and other assets of the Trust, if any, after meeting all the expenses and liabilities will be handed over to any other similar Trust or Institution similarly satisfying the requirements of Income Tax Act and as approved by the appropriate authorities of Income Tax or any other Government authorities.

44. The Trust hereby created shall be irrevocable provided however that the Trustees, by a resolution passed by an unanimous board be entitled to alter any of the provisions of these presents provided further that the Trustees shall in no event be entitled to alter and/or delete any of the objects of the Trust as particularly enumerated in Clauses 4, 5 & 6 herein above and the preamble.
